Donor names, addresses, and any other personal data provided will be used only by FTMC and its programs. FTMC publishes a list of the names of donors in an annual report which is available on the FTMC website. FTMC respects all donor requests to be anonymous.

Electronic Personal Records

Donor information is maintained in a secured database, and only authorized personnel have access to this information and only for appropriate purposes.

FTMC does not rent, sell, give away, or trade its donor lists or any information contained on those lists. Information Collection, Use, and Sharing

We are the sole owners of the information collected on this site. We only have access to/collect information that you voluntarily give us via email or other direct contact from you. We will not share your information with any third party outside of our organization. Unless you ask us not to, we may contact you via email in the future to tell you about changes to this privacy policy.

Security

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline. Wherever we collect sensitive information (such as credit card data), that information is encrypted and transmitted to us in a secure way. You can verify this by looking for a closed lock icon at the bottom of your web browser, or looking for "https" at the beginning of the address of the web page. While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only employees who need the information to perform a specific job (for example, billing or customer service) are granted access to personally identifiable information. The computers/servers in which we store personally identifiable information are kept in a secure environment.

Refunds
